





# Project Manual workshop 02-4

"Port Marketing and Public Relations" December 05 - 09, 2005, Riga (Latvia)











#### **Dear Partners:**

Following is a brief description of what you need to know having arrived at the Riga International Airport.

#### Currency

One of the first things to do right after you have landed successfully at the Riga International Airport and gone through the passport control is getting some cash money in local currency (lats). The exchange rate is approximately 1 EUR = 0.7028 LVL, or 1 GBP = 1.049 LVL.

We recommend exchanging some already at the airport because taxis mostly accept cash, although some might take credit cards too. The exchange rate in the city is better, of course, but you would only need some LVL 10-15 for the taxi and maybe something more for a small expense in the evening, if you happen to arrive late in the evening and banks are closed; normally they work till 18:00. Apart from that, payment cards are accepted widely in hotels, stores, restaurants, bars, etc.

### **Transportation**

In order to get you from the airport to the hotel ("Reval Hotel Latvia", Elizabetes street 55, http://www.revalhotels.com/eng/latvija/) you can either use taxi or public transportation (bus No 22 A), if you wish. The bus stop is just some 50 meters off (to the right) when you go out of the airport. It takes some 20-30 minutes on a bus to get to the city center. The fare is 0.25 LVL and you have to get off at the Katedrāle (Orthodox Cathedral), which is just next to the hotel.

However, we suggest to take a taxi- it is still more convenient. The fare to the hotel should not exceed 10 LVL; it can be a little more, due to the traffic in the city. The distance from the Riga International Airport to city center (the hotel) is about 15 km.

#### Weather conditions

We suggest you dress warmly and have your coats with you when coming to Riga in this time of the year- this concerns especially friends from the South of Europe. The air temperature in December can vary a lot: from +5 C to -10 C. Hopefully, we are lucky to have warm weather.







#### Hotel

All PORT-NET partners have accommodation booked at the *Reval Hotel Latvia*, a four-star hotel, which lies in the very center of Riga and has picturesque view of Riga from most rooms. It is the largest hotel in Riga, dedicated to providing comfortable accommodation, friendly service and attention to your individual needs. *Reval Hotel Latvija* has been a landmark of Riga more than 20 years.
